- B. Reclassification of LCSA-Metro Act The Village started receiving monies for the Michigan Local Community Stabilization Authority Act (LCSA Metro Act) in 2014. These funds were set-up under Major Street/Revenue [page 6 of "June 2019-20 Budget (on file)] and Local Streets/Revenue [page 7 of "June 2019-20 Budget" (on file)]. They are to be used for fire protection and police protection, therefore, they have been reclassified and listed as LCSA-Metro Act under General/Fire/Revenue [page 3 of "June 2019-20 Budget (on file)].
- C. General/Major CD This CD should be callable July 27, 2019. At that time \$100,000 will go into General and \$50,000 will go into Major.
